This Tuition Payment Contract sets forth the tuition payment policies of Corpus Christi School

Corpus Christi School requires all parents who have enrolled their child/children for the 2017/2018 school year to complete, sign, and return this Contract to the school office. Failure to sign will result in your registration being considered incomplete, and your child(ren) **will not be guaranteed a place in Corpus Christi School for the 2017-2018 school year.**

Tuition Payment Obligations

- If applicable, you will remain current with your 2016-2017 tuition payments; otherwise, your registration for the 2017-2018 school year will be returned and your child(ren) will not be guaranteed a place in Corpus Christi School.
- The 2017-2018 Family Registration Form, along with this 2017-2018 Tuition Payment Contract, will be signed and returned to Corpus Christi School by **April 5, 2017**. A non-refundable \$200 Family Registration fee (FRF) will be charged to your FACTS account payable on May 15, 2017. Payment of this family registration fee will coincide with the terms of your 2016-2017 FACTS agreement unless otherwise requested in writing to the Corpus Christi School office.
- **All** tuition payments will be handled by FACTS Tuition Management.
 - If you are new to Corpus Christi School, once you have submitted your registration form and your Tuition Payment Contract, you must complete a 2017-2018 FACTS enrollment form. When your tuition payment account with FACTS has been set up, the \$200 Family Registration Fee will be charged to the account. Payment of the FMF is due within 30 days. The tuition installment option plan payments through FACTS begin July, 2017.
 - If you are a returning family, once you have submitted your registration form and your Tuition Payment Contract, your tuition will be entered into the FACTS system.

- Information will be provided to you by FACTS regarding instances of insufficient funds and fees incurred. As these are FACTS fees, they must be paid to FACTS directly.
- Admission for the 2017-2018 school year will be denied if tuition payments are not current prior to the start of school.
- Eighth grade students whose tuition obligations are not satisfied in full will not be permitted to participate in the eighth grade activities.
- For families who withdraw their child(ren) during the school year, they will be charged for the number of days the student(s) were enrolled at Corpus Christi School.
- Nothing in this contract in any way limits the rights of Corpus Christi School to suspend or dismiss my child(ren) for just cause. I agree that I give all Corpus Christi School's rules and regulations my endorsement and cooperation.
