Tuition must be paid in full using either of the following options: (Please check which option you prefer)

**Full payment of the net tuition, less \$40.00 PER FAMILY, is paid on or before June 10, 2016.** All families choosing this option are required to submit full payment for their family's 2016/2017 tuition once they have submitted their registration/materials fee and the 2016/2017 Family Tuition Agreement to the school office.

Full payment of the net tuition is paid using the FACTS Management plan. FACTS payments are broken into ten (10) installments beginning July, 2016 and ending April, 2017 for families who register on or before June 10, 2016. Comparable monthly installment plans (ex: 9 month, 8 month, etc...) may be necessary depending on the date of registration. All FACTS installment plans should be completed by April, 2017. All families choosing this option are required to submit tuition payments directly to FACTS.

**I understand and agree to the following:**

I have read the above Tuition Agreement for the 2016 – 2017 school year at Corpus Christi School and agree to the tuition payment plan chosen above.

**For families who withdraw their child/children during the school year, they will be charged for the number of days the student(s) were enrolled at Corpus Christi School. (Must Initial \_\_\_\_\_)**

If I do not meet my tuition obligations, Corpus Christi School may follow the policy of the Archdiocese of Hartford – Students whose tuition is not current by the end of the first semester (second quarter) shall be denied admission for the second semester (third quarter) unless other tuition payment arrangements have been made with the Pastor/ Chief Administrator.

Students whose tuition and fees are not current at the end of the school year shall be denied admission for the next school year unless other tuition payment arrangements have been made with the Pastor/Chief Administrator.

Nothing in this agreement in any way limits the rights of Corpus Christi School to suspend or dismiss my child for just cause. I agree that I give all Corpus Christi School's rules and regulations my endorsement and cooperation.
